## Minutes of the Parish Council Meeting

Held on Tuesday 18<sup>th</sup> May 2021 in the Brinkworth Village Hall

## **Public questions**

Fifteen members of the public attended the meeting.

A resident from Stoppers Hill spoke regarding the local footpaths. The gentleman leads a local rambling group. He is concerned about the general state of the local footpaths and the lack of signage, the poor state of the stiles and some of the paths have been blocked by the landowners. The gentleman is also very concerned about the state of the footpath on Sommerford Common. Wiltshire Councillor Threlfall took his name and promised to put him in touch with the chair of the Footpath Group.

14 Residents from Callow Hill came to the meeting to express their concerns regarding the proposed building of a car auctions on Callow Park which was posted on 12<sup>th</sup> May. The prospective site is already advertising for staff on line and work has already been carried out on the south side of the building to accommodate a new entrance. According to the online site, the sale of 'super cars' will commence on 1<sup>st</sup> July. The residents asked how the owners secured Change of Use without any consultation. It was unanimously felt that, due to noise, rural site, narrow lane, residential area and increase traffic this planning should not go ahead. It would appear that the owners have significantly jumped the gun and the enforcement officer has been alerted but due to Covid there is a delay in inspections. Wiltshire Councillor Threlfall will speak to the planning officer. All residents were recommended to write individual letters to lodge their complaints. Councillor Millard suggested that the residents also write to Highways to lodge their complaints with regard to increase traffic.
